**Economic** • property values and occupancy rates are higher on tree-lined streets

**Social** • trees strengthen communities and provide social, psychological, and aesthetic benefits

**Health** • urban vegetation slows heartbeat, lowers blood pressure, and relaxes brain wave patterns

#### **Environment**

• sequesters carbon created by idling cars, creates cooling effect on urban heat islands, conserves water, and filters air

### **Bear Resistant Trash Receptacles**

Area West of I-95 Corridor | Zone 4 | Enhancement of Connections & Corridors

The project consists of the purchase of 125 bear-resistant garbage cans to provide to citizens at a reduced cost.

# **Minimizing Human-Bear Conflicts**

#### **Protects People & Property**

Bears love to find easy meals and unsecured trash is the number one bear-attractor in residential areas. Bears (and other wildlife) that become food-conditioned are more likely to return to neighborhoods - causing property damage and interacting with humans. Using bear-proof trash cans helps deter bears from associating homes as a food source.

#### **Protects Bears**

Bears that spend more time in a neighborhood reduce their chance of survival, as they are more exposed to vehicle strikes, illegal shooting, or trapping and removal.

## **Riverfront Park**

NE of International Speedway Blvd and Beach St | Zone 3 | Major Redevelopment & Transformation

The Florida Inland Navigation District assisted the City of Daytona Beach with the cost of the day docks design and construction allowing the city to better capitalize on the waterfront by providing additional access for boaters to the city's historic downtown and Riverfront Park.

After docking, visitors can explore the Angell & Phelps Chocolate Factory that was established in the 1920's.

# CITY ACQUIRES MULTI-PURPOSE VESSEL WITH ASSISTANCE FROM FLORIDA INLAND NAVIGATION DISTRICT

The Florida Inland Navigation District assisted the City of Daytona Beach with the purchase of a new boat to enable the City to better respond to emergencies on and around the City's 5 miles of waterway.





# Providing boater safety in Daytona Beach Waterways

The vessel is used by the Fire Department, Police Department and Permits & Licensing Division for marine emergency services, law enforcement and building code enforcement for structures located on and in the intracoastal waterway, including:

- Special purpose patrol
- Search and rescue operations
- Assisting the boating public
- Assisting in salvage operations
- Providing a visible deterrent
- Promoting boating safety through education
- Enforcing Federal, State and Local maritime laws
- Participating in special operations with other agencies
